

APPENDIX

BY-LAW NUMBER 88-100 OF THE CORPORATION OF THE CITY OF KITCHENER

(Being a by-law to adopt a Municipal Code)

The Council of The Corporation of the City of Kitchener, pursuant to Section 105 of the *Municipal Act*, R.S.O. 1980, Chapter 302 and Section 27(g) of the *Interpretation Act*, R.S.O. 1980, Chapter 219, enacts as follows:

1. The By-laws of The Corporation of the City of Kitchener listed in Schedule 'A' attached hereto, hereinafter called the "Concordance," are hereby approved and consolidated into chapters of a comprehensive by-law attached hereto as Schedule 'B', which shall hereafter be known as "The City of Kitchener Municipal Code" and is hereinafter called the "Municipal Code."
2. The Municipal Code is a consolidation and continuation of the provisions of the original by-laws listed in the Concordance and the provisions of the Municipal Code which correspond to the provisions of an original by-law shall be deemed to have come into force on the date that the original by-law came into force.
3. Any condition precedent or subsequent or the approval of any authority external to the Council required by law before an original by-law came into force shall, where such condition was satisfied or approval obtained in respect of the original by-law, be deemed to have been satisfied or obtained in respect of the corresponding provision in the Municipal Code in all respects as though the condition had been satisfied or the approval obtained in respect of that provision in the Municipal Code.
4. The Council may direct at any time that a by-law passed under its jurisdiction be made a part of the Municipal Code, in which event it shall be added to the Concordance and shall be arranged and numbered so as to fit within the scheme of the Municipal Code, notwithstanding that the by-law in its original form was not so arranged and numbered.

5.
 - (a) An amendment to a chapter of the Municipal Code may be made directly to the Municipal Code and shall be deemed to be an amendment to the corresponding by-law listed in the Concordance, or
 - (b) An amendment may be made to a by-law listed in the Concordance, in which event it shall be added to the corresponding chapter of the Municipal Code and shall be arranged and numbered so as to fit within the scheme thereof, notwithstanding that the amendment in its original form was not so arranged and numbered.
6. Each Section (upper case "S") of the Municipal Code, found in the left margin of each page thereof, consists of three numerical elements to identify, in order, the chapter, article and section (lower case "s") in which a provision of the Municipal Code is found, and the citation of all numerical elements of a Section shall constitute identification of the appropriate section of the Municipal Code for all purposes, including judicial or legal proceedings.
7. The preface, headings, marginal notes and references to original by-laws in the Municipal Code form no part of the Municipal Code but shall be deemed to be inserted for convenience of reference only.
8.
 - (a) The Clerk shall retain in his records for safe-keeping an original copy hereof, including the Concordance and the Municipal Code;
 - (b) The Clerk shall be responsible for inserting into the Municipal Code all amendments thereto and all by-laws directed be made a part thereof so as to keep the Municipal Code up-to-date;
 - (c) The Clerk shall keep a certified copy of the Municipal Code available at his office for use and reference by the public; and
 - (d) The Clerk shall provide copies of the Municipal Code or parts thereof to the public for such fees as are prescribed by resolution of Council.
9.
 - (a) No person shall alter, tamper with or change, by an addition or deletion, any part of the Municipal Code or certified copy thereof so as to misrepresent its content; and

(b) Every person who contravenes this Section is guilty of an offence and is liable, upon conviction, to a fine not exceeding Two Thousand Dollars (\$2,000), exclusive of costs, for each offence.

10. The holding of any section or part section hereof to be void or ineffective for any reason shall not affect the validity of the remainder of this by-law.

11. This by-law, excluding Schedule 'B' hereto, shall be attached as an appendix to the Municipal Code and form part thereof.

12. This by-law shall take effect immediately upon its enactment.
