**50.1.3 Schedules - set out**

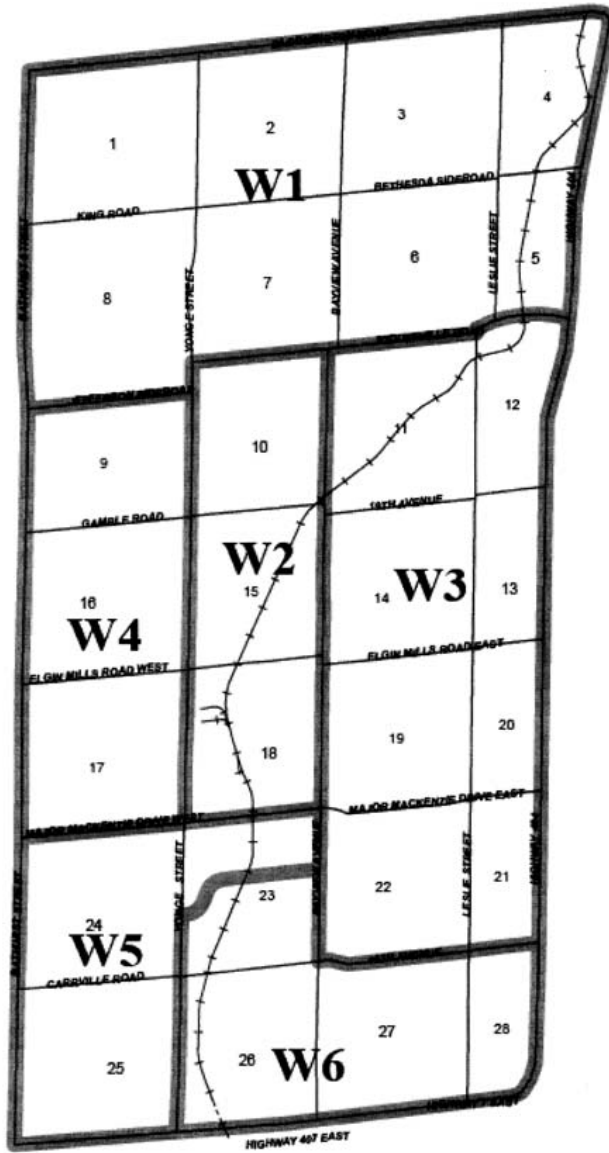

### Schedule 'B' - Ward Boundaries - description

#### **WARD ONE (1)**

Ward 1 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Bloomington Road to the north, extending west from the centre line of Highway No. 404 to the centre line of Bathurst Street; extending south on Bathurst Street to the centre line of Jefferson Sideroad; extending east on Jefferson Sideroad to the centre line of Yonge Street; extending north on Yonge Street to the centre line of Stouffville Road; extending east on Stouffville Sideroad to the centre line of Highway No. 404; extending north on Highway No. 404 to the centre line of Bloomington Road.

#### **WARD TWO (2)**

Ward 2 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Stouffville Road to the north, extending west from the centre line of Bayview Avenue to the centre line of Yonge Street; extending south on Yonge Street to the centre line of Major Mackenzie Drive West; extending east on Major Mackenzie Drive East to the centre line of Bayview Avenue; extending north on Bayview Avenue to the centre line of Stouffville Road.

#### **WARD THREE (3)**

Ward 3 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Stouffville Road to the north, extending west from the centre line of Highway No. 404 to the centre line of Bayview Avenue; extending south on Bayview Avenue to the centre line of Sixteenth Avenue; extending east on Sixteenth Avenue to the centre line of Highway No. 404; extending north on Highway No. 404 to the centre line of Stouffville Road.

#### **WARD FOUR (4)**

Ward 4 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Jefferson Sideroad to the north, extending west from the centre line of Yonge Street to the centre line of Bathurst Street; extending south on Bathurst Street to the centre line of Major Mackenzie Drive West; extending

east on Major Mackenzie Drive West to the centre line of Yonge Street; extending north on Yonge Street to the centre line of Jefferson Sideroad.

### **WARD FIVE (5)**

Ward 5 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Major Mackenzie Drive to the north, extending west from the centre line of Bayview Avenue to the centre line of Bathurst Street; extending south on Bathurst Street to the centre line of Highway No. 7; extending east on Highway No. 7 to the centre line of Yonge Street; extending north on Yonge Street to the centre line of Weldrick Road; extending east on Weldrick Road to the centre line of Bayview Avenue; extending north on Bayview Avenue to the centre line of Major Mackenzie Drive East.

### **WARD SIX (6)**

Ward 6 to consist of the portion of the Town of Richmond Hill described as follows:

Beginning at the centre line of Weldrick Road to the north, extending west from the centre line of Bayview Avenue to the centre line of Yonge Street; extending south on Yonge Street to the centre line of Highway No. 7; extending east on Highway No. 7 to the centre line of Highway No. 404; extending north on Highway No. 404 to the centre line of Sixteenth Avenue; extending west on Sixteenth Avenue to the centre line of Bayview Avenue; extending north on Bayview Avenue to the centre line of Weldrick Road.
